# **Message from the Executive Director**

Dear Colleagues:

It is that time of year again. Last month, the Governor proposed his Fiscal Year 2016 budget to the New Jersey Legislature, and next month the Secretary of Higher Education, college/university presidents, and I will testify before the Senate and Assembly Budget committees.

Once again, Governor Christie has demonstrated robust support for student aid, particularly the Tuition Aid Grant (TAG). The Governor proposed total TAG expenditures of \$385.830 million, which includes an additional \$11.095 million for the current fiscal year, as well as an additional \$19.574 million in Fiscal Year 2016. Should the Governor's proposal be adopted by the Legislature, all awards in all eligibility indexes will increase in Academic Year 2015-2016.

The proposed budget also includes sufficient funding to meet demand for the Part-Time TAG for County College Students program, the Governor's Urban Scholarship, NJ STARS and NJ STARS II.

I encourage the financial aid community to let your legislators know the importance of these programs to the students you serve. The dates and times of the budget hearings are listed on Page 2 under Upcoming Events. These hearings are open to the public, and individuals who cannot attend can listen on line at www.njleg.state.nj.us.

#### **Spring Predisbursement Roster Sent**

It is extremely important that you carefully review your second spring predisbursement roster and cancel awards for all students who are not enrolled, are enrolled for less than the required number of credits, are not making SAP, etc. Last year, HESAA was unable to make a spring payment until June because some institutions did not cancel awards in a timely manner. This may be the case again this spring if all institutions do not thoroughly review and update the second spring pre-disbursement roster due April 17.

## Millennials Give New Jersey High Marks for Student Aid

New Jersey gets an "A" for state aid to students. So says The Young Invincibles (YI), a national Millennial research and advocacy group. In its recently released report, YI provides a look at U.S. higher education funding. Grades for state aid were based on three measures: average grant per student, average need-based grant per student and how the grants make up the overall higher education budget.

Given how much more the maximum TAG award is versus the maximum Pell award, as demonstrated below, it is easy to see how New Jersey earns its "A".

#### **HESAA Promotes Financial Literacy**

Two recent academic studies reveal the striking difference between men and women when it comes to knowledge of financial concepts. The studies found that women of all ages – and across countries – have a lower degree of financial literacy than men, and are also less likely to feel confident about money matters.

At HESAA, promoting financial literacy is a key component of our outreach activities. Through our Real Money 101 financial literacy workshops, we teach students the basics of money management: managing a checkbook, the value of saving and the basics of credit.

From September 2014 through February of this year, HESAA has given over 100 Real Money 101 workshops throughout New Jersey, according to Financial Literacy Program Manager Samantha Benson.

#### **Coming Soon: Going Paperless**

HESAA is ramping up its paperless services. Starting sometime in April, borrowers will have the option of eliminating paper bills, and receive an email notification when the bill is ready to be paid. Borrowers can log in, review the bill and pay it if they wish to, all in one easy trip to HESAA.org.

### **Understanding NJCLASS Eligibility for Summer Sessions**

Students enrolled in an institution's summer or winter mini-session <u>are eligible for NJCLASS</u> loans as long as their <u>annual enrollment status at least half-time</u>. Students maintain their NJCLASS eligibility, even if their summer or winter mini-session credit hours are less than half-time.

For example, Sallie Jones is a student at your institution during AY 2014-15. She enrolled for six credits during the fall, 2014 semester and spring 2015 semester. Sallie would like to enroll for three credits during the summer 2015 mini-session, but she needs a loan to do so. Sallie is eligible for an NJCLASS loan for the summer term, since she was enrolled at least half-time during the academic year. #### **Training Tip**

What do you do if a student's HESAA record



has an "invalid address" indicator?

Aid administrators should submit an online New Jersey Change Form (NJCF) to correct an error in the address. NJCFs are processed overnight. The following business day, aid administrators can check the Grants Master Display page to confirm the change has been processed and the invalid address indicator has been removed. The correction will also trigger HESAA to resend to the updated address any prior communication sent from HESAA to the student but returned due to the invalid address.

## **Update on Consumer Financial Protection Bureau (CFPB)**

In our Winter 2014 issue of *New Jersey Assistance Advisor* we wrote about the CFPB's focus on schools' use and marketing of "campus affinity products," which are financial products and services offered by a bank or other financial institution and which bear the logo of the school or are otherwise endorsed by it.

We previously advised that the CFPB is concerned that these products carry undisclosed or improperly disclosed fees and are generally less advantageous to students than traditional, non-affiliated accounts and services. On January 14, 2015, the CFPB announced action to address this concern by way of seeking input on a new "Safe Student Account Scorecard."

The CFPB cites the idea behind the Scorecard as a tool to evaluate the costs and benefits of these products. The scorecard will specifically ask financial institutions to provide schools with a clear description of product fees and features, full disclosure about the financial institutions' marketing practices, how much the financial institution earns from the accounts, and an annual summary of fees. The CFPB suggests institutions of higher education include the scorecard as part of any RFP that partners the school with a financial institution for campus infinity products. We suggest schools monitor this issue for further development, as it may impact your relationships with financial services vendors.
