Message from the Executive Director

Dear Colleagues:

At HESAA we are always striving to improve our products and services to better meet the needs of our students and their families.

Given the low interest rate environment, several students and parents have asked us to consider offering a variable rate loan through our NJCLASS program. In response, HESAA developed a variable rate product for the coming academic year.

The new NJCLASS variable rate product will be based on the 3-month LIBOR plus 4.25%. For AY 2014-2015, the initial variable rate will be 4.49%. The interest rate will reset quarterly, but the borrower's monthly payment will only be adjusted annually. The term is 10 years and borrowers are required to make both principal and interest payments immediately following disbursement of the loan. Unlike the fixed rate NJCLASS products, the variable rate loan has no origination fee. Like all NJCLASS loans, there is no prepayment penalty. Finally, the best feature of HESAA's variable rate product is the maximum interest rate cap of 9.5%. Therefore, in the unlikely event that interest rates soar, borrowers will have the assurance that their rate will not exceed 9.5%. This feature is unique among currently offered variable rate student loan products.

NJ-GIVS: Program and Eligibility Criteria Changed

The New Jersey Governor's Industry Vocations Scholarship (NJ-GIVS), has been expanded to serve more students.

The following changes will be in effect for the upcoming 2014-2015 academic year:

- Program expanded to include both certificate and eligible degree programs;
- Programs of study added: carpentry, plumbing, electrical trades, welding and masonry;
- Changes to income eligibility: Student NJEI score below 10,500 replaced with student annual household income of below \$60,000; and
- Eligible institutions expanded to include technical/vocational and proprietary trade schools associated with a TAG participating institution.

Schools Asked to Certify GUS Persistency Awards by June 13

Spring 2014 graduates who received awards through the Governor's Urban Scholarship (GUS) program are eligible for a persistency award in the amount of \$500. Eligible students will have graduated from a community college with an Associate's degree, or a four-year institution with a Bachelor's degree.

HESAA requests that schools certify students for this award by June 13, 2014. Institutions can see the list of eligible students by logging on to <u>www.hesaa.org</u>. Administrators should select "GUS Persistency" under the NJ Grants & Scholarships tab and place a check mark in the column labeled "Is Eligible to Receive Persistency Award". Please sign and exit form. If no students are eligible, simply sign and submit the form to confirm your review.

Once you have certified your students, HESAA will notify students of their award. HESAA policy dictates that awards must be sent to the certifying campus. Students have been instructed that their award will be reduced by any outstanding account balance and that the remaining funds will be issued by the school as a refund.



Loans

NJCLASS interest rates for AY 2014-2015 are now available. NJCLASS variable rate loan, 10 year fixed rate loan and 15-year fixed rate loan all have interest rates below the federal PLUS loan. Below are the NJCLASS loans, rates, terms and fees.

	Rate	Repayment of Principal and Interest	Term	Fee
NJCLASS 10-Year Variable Rate of 4.49% new	Based on 3-month LIBOR + 4.25% Capped at 9.50%	Immediate repayment of principal and interest	10 years	none
NJCLASS 10-Year Fixed Interest Rate of 5.99%	5.99 fixed	Immediate repayment of principal and interest	10 years	3%

Compliance and Quality Assurance

With the upcoming academic year-end fast approaching, it is important for institutions to remember to perform their year-end reconciliation of State award funds. Each institution must ensure that an academic year-end reconciliation of the Financial Aid Office records, Accounting Department records (general ledger) and the Bursars' Office records (student accounts) is performed each academic year end (June 30). The institutional individual award values, as well as program totals, for these three departments should match exactly the value of awards reflected on HESAA's final roster. Any changes in student award values must be reported to HESAA no later than the end of the academic year. Any associated refunds due the State must also be submitted to HESAA no later than June 30.

It is also important to remember to close out all State grant fund accounts each academic year end. Grants and Scholarships are awarded for an academic year and must be awarded by June 30; all general ledger accounts pertaining to State awards must have a zero balance to begin a new academic year on July 1. Funds are not to be carried over or commingled with funds from other academic years.

Failure to accurately reconcile award funds can adversely affect a student's future award eligibility.
